2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The Easter period meant we could not work on two holidays (we had planned not to work on Sundays anyway as the community is very religious); there was also ANZAC Day later in the month, so another day was lost. My solution was to get as much work as possible completed in the early part of the expedition and to remain very flexible with daily work programmes.

3. Briefly describe the three most important outcomes of your project.

- i) Determining the <u>current status</u> of turtles at the atoll. Quantifying the nesting activity and species present. This will allow population trends to be compared over time.
- ii) Raising awareness with the islanders that sea turtles are endangered; and promoting them as an important local and national resource.
- iii) Training several islanders as research assistants.



4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

- i) The Island Council approved this research and gave permission to teach in the school.
- ii) The school Principal and teachers facilitated in our teaching day: all students learned new things and some practical or artistic skills (ages ranged from 5-19).
- iii) Five teenagers (aged 16-19) worked with us as research assistants. They were each amazed and inspired by our research: at least two will continue to work with us in the future.
- iv) Three other islanders participated in an 'open day' of nest excavations.
- <u>All</u> the community attended our final presentation where we explained our findings, the importance of our work and their stewardship of natural living resources; and our plans for the future. Two of our local researchers spoke during the presentation.
- vi) The island Council expressed great interest in our findings and they are willing to support any necessary conservation measures (these will be formulated during another study).

5. Are there any plans to continue this work?

Yes. A future study will concentrate on nesting dynamics and ecology; extending the training of our local researchers; and an assessment of the outer reef underwater habitats.

9. Looking ahead, what do you feel are the important next steps?

- i) To undertake fieldwork during the nesting season: this will be challenging as it coincides with the cyclone season and transportation is extremely rare. The likely solution is for a researcher to go to Palmerston for about 6 months, and train local researchers how to measure, tag and collect genetic samples from nesting females.
- ii) A comprehensive underwater assessment should be conducted: searching for hawksbill turtles in particular.
- iii) To determine if conservation measures are actually needed, or whether current levels of direct take are sustainable (they probably are).
- iv) To consolidate an electronic support network for local researchers; to extend their data collection capabilities.
