1. Survey of the Fish population in Man Sagar lake			Yes	The fishing contract in the lake had been terminated in 2006. There was no culling after that and fish stock had assumed alarming proportions. It was essential to survey the fish species as some of them impact its aquatic character. It was accomplished to realise the lake's ecosystem and a letter from Fish Department was procured to authenticate our survey work. It was carried out through local fishermen.
2. Survey of the aquatic vegetation in Man Sagar lake			Yes	After the first de-silting initiative by the government was made in Man Sagar Lake (2002), lot of vegetation got uprooted and benefits from aquatic vegetation to the lake water were denied. The survey now done has established deficiency of such vegetation to throw light on health of the lake's ecosystem. Rooted and floating species were found most missing.
3. Dialogues with government		Yes		The above two survey-results were conveyed to the government through letters and meetings and the dialogue continues as it is un-ending process.
4. Dialogues with stake holders		Yes		They are continuing and will be continuing. 		2013 (CSE Round-table), and in Jaipur on 8 February 2013 (at government level at HCM RIPA), it is further to be discussed in New Delhi on 4 and 5 March 2013 (CSE's Anil Agrawal Dialogue); these are first such and positive developments for this lake conservation.

No unforeseen difficulties were faced. Difficulties are part of the process especially in a country like India.

(i) The Lake Development Authority being set up in Rajasthan and Man Sagar Lake is poised to be show cased as an example before government and civil society all over India as a result.

(ii) The fish survey undertaken is a first effort of its kind for lakes in this State (Rajasthan).

(iii) The aquatic vegetation survey is yet another first to spell out health of this lake's ecosystem.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The people living around this lake by now have realised their satisfaction out of the initiatives made through this RSG recipient, holding Birding Fairs to enlist civil society's support and showcasing merits of aquatic ecosystem of this lake (the news reports and blogs, cited above, testify it).

(a) The invasive fish species (as also highlighted by the Fish Department vide its letter to the RSG recipient, copy already sent to RSG) will need to be removed from this lake to free its water from their negative impact, and

(b) The aquatic vegetation thus surveyed will need to be reintroduced in the lake to serve as cleansing agent for water and also feed for birds to further enhance water quality.
