### 2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

We had no unforeseen difficulties.

#### 3. Briefly describe the three most important outcomes of your project.

- 1. School pupils learned how to evaluate the present condition of forest. Identify the composition of trees and land cover by plants. Using new devices and create dataset for farther analyses.
- 2. Participants learned how important are chestnut and oak trees for their district and how to protect it. They learned that chestnut natural growing is one of the biggest in Georgia and there are several disputed species of oaks, which are grown in their region.
- 3. Students made presentations and they present 10 themes on different subject: ecology, pest management, forest importance, conservation, etc. We reviewed all these works and evaluated and finally we gave certificate to the winner, second place and third place. So students got motivation to participate in this kind of project and they asked to us to continue such projects and work with them. Teachers of each school were actively involved in our project as well.



## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The municipality government helped to as to contact to school directors, who selected teachers who were in direct contact with us to help in organisational things.

#### 5. Are there any plans to continue this work?

We are planning to develop and continue our works in Borjom-Kharagauli National Park. For the next step we will find touristic routes, which will show to locals and park visitor's present condition of chestnut and oak trees in the forest. This route will be named after Rufford Foundation, if the foundation will give us this permission.

This route will be separated as vertical zonal characteristics, so chestnut and oak zones will be separate, and all biodiversity elements representing the given zones will be given on the information desks placed on the routed on their respective locations. This will serve as an eco-guide for tourists as well.

#### 6. How do you plan to share the results of your work with others?

The leaflet about the project published during the project will be distributed to the schools and to local municipalities. During our field studies and travel we will present our data to nonparticipant schools of the district and also to other districts of Georgia. It will be published also in the local newspaper and it will give to local's information about Rufford and our activities.

As money was transferred in April, RSG was used since April 25, 2012 and final step we completed in April 20, 2013.
