Study the current state of rare and endangered plant species and develop scientific recommendations.			Yes	The current status of rare and endangered plant species determined through conducted studies in Baljuvon and Shurobod districts, eastern Khatlon, Tajikistan.  As a result of conducted studies seeds of the new plant species was collected and introduced in Alive Red Book demonstration plot in the Kulob Botanic Garden.  Moreover, scientific recommendations were developed based on research findings and results and recommendations were shared with Environment Protection Department of the Republic of Tajikistan and Academy of Sciences of the Republic of
Conduct awareness raising campaigns for rural inhabitants and representatives of respected state agencies.			Yes	Tajikistan.  Meetings and other events were conducted with Education and Ecology departments of Kulob town and target districts, in order to maintain close links with them, as well as to involve secondary schools and schoolchildren in the project.  As a result, necessary information regarding rare and endangered plant species was provided through mini lectures in secondary schools to pupils to form the ecologically friendly views towards natural resources.  As a part of awareness raising campaign, seminars in Baljuvon and Shurobod districts were conducted for rural inhabitants as well as representatives of respected state agencies. The main aim of the seminars was to inform the population about the



importance of preservation and
protection of these plant species
through seminars and to give
information regarding rare and
threatened plant species.
Moreover, week of open doors was
conducted in Kulob Botanic
Garden, to demonstrate to
participants of week of open doors
how the rare and endangered
species look like, importance of
their existence, their contribution
on balancing of ecosystem etc.
Conducting direct meetings and
awareness campaigns consider one
of the effective methods of
conveying messages to target
population. In order to strengthen
the result of the conducted events,
informative brochures and leaflets
were prepared and distributed to
participants of the conducted
awareness events.
In line with the project work plan, a
photo exhibition "SOS" was
organised through demonstration
of taken photos regarding the
current state of rare and
endangered species. During photo
exhibition participants had
opportunity to obtain informative
materials and ask questions
regarding the state and importance
of the rare and endangered
species. In addition, information
materials were distributed to
participants of awareness raising
campaigns.

## 2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The main difficulty which our team faced was travel issue during field visits. Due to price increase on fuel and food additional funds were spent for travel and transportation from PO "Ganji Tabiat" funds.



#### 3. Briefly describe the three most important outcomes of your project.

- Environment Protection Department of the Republic of Tajikistan, Academy of Sciences of the Republic of Tajikistan and International Union of Nature Protection (IUNP) plan to update the Red Book of Tajikistan and proposed PO "Ganji Tabiat" to collaborate in this initiative through identification of plants species as per determined criteria by the Ecology and Environment Protection Department. Within the framework of the RSG project, we already started conducting similar research and identifying the current state of the rare and endangered plant species. The project was implemented in very good period and the project results reached the national level, which our team did not even expect. This was one of the most important outcomes of the project as well as significant contribution to protection and conservation of nature in Tajikistan.
- According to research findings, six rare and endangered plant species were newly identified and planted in the demonstration plot "Alive Red Book". This was considered as one of the most important outcomes, as the main purpose of the project is conservation of the rare and endangered plant species. The list of the identified plant species stated under:
- Juno rosenbachiana (Regel) Vved.
- Allium karataviense Regel
- Allium gigantheum Regel
- Allium trautvetterianum Regel
- Fritilla riaregelii A. Los.
- Eremurus albertii Regel
- For the first time in Kulob town, was conducted photo exhibition of the rare and endangered plant species. What is more, participants of the photo exhibition and other awareness campaigns conducted within the framework of the RSG project received necessary information concerning importance of the project activities and conversation of Nature as a whole.

### 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Local communities were involved in the project by participation in seminars, week of open doors, photo exhibition and meetings. Moreover, prepared information leaflets and brochures were distributed to population of target areas as well as to respected state agencies and organisations.

#### 5. Are there any plans to continue this work?

We stay positive towards continuation of this work in future, as we managed to bring the results of this work up to national level and build stronger links with respected state agencies within Tajikistan. Conservation and protection of nature is an ongoing process and in future we hope to achieve higher and better results.



#### 6. How do you plan to share the results of your work with others?

The project results will be shared during future meetings and events with local NGOs, nature protection state agencies, international NGOs and field visits through presentations, articles and distribution materials.

### 7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

The project was anticipated for 10 months (January 1<sup>st</sup> to October 31<sup>st</sup> 2013) and we have successfully managed to fulfil all project activities by the due date.

#### 9. Looking ahead, what do you feel are the important next steps?

We are going to modify the methods of our work and adapt it with the received suggestions from target population as well as respected state agencies on protection of nature in Tajikistan. One of the suggestions proposed by the target population of Baljuvon district, Sari Khosor village was, instead of using scientific names of selected rare and endangered plant species, using their local names, which will be more understandable for the rural population. In this regard, PO "Ganji Tabiat" plans to prepare and distribute a simple introductory brochure particularly for the rural inhabitants.

Yes, we used the RSGF logo in leaflets, banners and booklets, Moreover, the RSGF logo was displayed during seminars, week of open doors and photo exhibition.
