2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The unforeseen difficulty we encountered was the inability to get a hall or space that could accommodate the large number of community members who wanted to watch conservation documentary. The available space could only accommodate up to 30 people. To address this difficulty the team made arrangements to repeat the documentary in each community twice or thrice depending on the number to ensure majority of the people benefited.

3. Briefly describe the three most important outcomes of your project.

- 50 anti-bush fire monitors were trained. Following the training of 50 anti-bush fire monitors, each of the trainees was tasked to train at least two more monitors in their respective localities to lead the education in their respective communities. As at the time of this report a total of 100 more anti-bush fire monitors have been trained by the 50 trained monitors bringing the totals to 150 resulting in multiplier effect for the project.
- Within the period there was considerable reduction is bush fire incidences in the target communities as compared to previous years, as well as reduction in poaching from the sanctuary. As a result of these improvements there is sustained fauna and flora within the sanctuary for the Mona monkeys to habitat.
- There is an increase in the bat population within the sanctuary especially around the waterfall following interactions with farmers and tour guides. During educational



sessions, the farmer and women groups indicated their desire to support the project and proposed alternative livelihood trainings in rodent rearing and beekeeping.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The target communities were actively involved in the planning and execution of the project. The target communities benefitted from anti-bush fire training, Mobile conservation education programme through video documentary, establishment of Green Clubs and their participation in peer to peer educational programmes.

5. Are there any plans to continue this work?

Yes, there plans to continue this work because the project has generated a lot of interest within the communities and the communities have accepted the overall project idea and are willing to participate in more educational activities in other to protect their environment. We plan to secure a second-year funding from the Prince Bernhard Fund for Nature to continue the project. However, in the coming year the project will carry out training in alternative livelihood options for farmer groups and women groups in rodent rearing, beekeeping, and also carry an impact assessment of the project after 3 years. The results will be shared on the website of Care Net Ghana.

6. How do you plan to share the results of your work with others?

The results of this project will be shared at Care Net Ghana website, newsletters, The Hohoe Municipal Assembly and the Tourism Committees of the municipality. Care Net Ghana is currently developing a data base for its conservation activities for its website and this project will be featured very prominently.

7. Timescale: Over what period was The Rufford Foundation grant used? How does this compare to the anticipated or actual length of the project?

12 months. The period is from February 2013 - January 2014. The project was supposed to have completed in January but had to be extended for five more months to be able to reach more communities due to lack of big space for documentary.

In order to create sustainable system for enriching conservation of the Agumatsa Wildlife Sanctuary, the team in collaboration with Care Net Ghana will continue to support the target communities to manage the various trained groups including the Green Clubs within the schools. Beyond this there is also the need for an integrated management approach in order to further reduce the unsustainable logging and hunting within the sanctuary. Also the there will be further training for famer and women groups on alternative livelihood options in rodent rearing and beekeeping as has been agreed by the beneficiaries.
