2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The strong devaluation of the Burundian currency until more of 30% entailed a blaze of the prices in all domains. This situation brought us to review some activities and to establish priorities.

3. Briefly describe the three most important outcomes of your project.

- 1. The communities participate in the activities of surveillance and management. They went as far as stopping the delinquents who destroy the forest. Signature of a Memorandum of understanding with communities.
- 2. A village of Batwa received a land, freeing the portion of the reserve that these Batwa occupied thus.
- 3. Great collaboration with authorities such as the mayor of the commune of Bururi, the Governor of the province of Bururi and other authorities in the protection of the forest reserve.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Since the activities of sensitisation for the integration of the communities in the protection and the management of the natural forest reserve of Bururi, the communities grouped in the associations lend strong hand to the rangers in the actions of surveillance. They participate in the actions of materialisation of the limit without requiring salary. The communities maintain regularly the parcel of the office of the reserve and the track reaching the office. The communities organise meetings of sensitisation of their neighbors regularly to the respect of this protected area. In the public meetings organised by the local administration, the representatives of the communities often give the messages inviting everybody to imply itself in the protection of the forest of Bururi. A committee composed of five members representing the communities has been elected and work of common agreement with the chief warden of this area. A memorandum of understanding between the direction of this reserve and the communities have been signed.

5. Are there any plans to continue this work?

Yes. The sensitisation is a long-term work. We are going to continue to plead for the group of Batwa (50 households) not having received an earth again so that they also receive a property because they exercise a strong pressure on the forest.



One of the reasons of the destruction of the reserve is poverty. While continuing the sensitisation, it is necessary to undertake the activities that reconcile development and conservation.

6. How do you plan to share the results of your work with others?

All along the execution of our project, we worked with four local radio stations that have every time relieved the information in relation with the collaboration with the communities in the protection of the biologic and eco systemic richness of the forest.

A paper that lists our experience of collaboration with the communities has been produced and has been distributed to all chiefs' wardens of the protected areas of Burundi.

On 30th September 2013, on invitation of the Director General of the National Institute for the Environment and the Nature Conservation in Burundi, I received occasion share, at Gitega, before all chief wardens of protected areas of Burundi, my experience of integration of the communities in the protection of the natural forest reserve of Bururi. I'll continue to share this experience through radio, television and workshops and leaflets.

7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

October 2012 and September 2013.

This period has been sufficient to implement the project.

9. Looking ahead, what do you feel are the important next steps?

- Continue to work with community to reinforce the protection of the natural forest reserve of Bururi.
- To help the communities to make some nurseries and to plant the seedlings in their own properties.
- To valorise some natural resources of the forest as water while helping the communities to build sources of drinking water.
- To teach the traditional healers how to make the harvest of some medicinal plants without putting them in danger and to promote the conservation ex situ of the medicinal plants in disappearance.

Yes, the logo has been used on the banners. The note carrying on the acquirements of the small grant and the learned lessons has the logo of RSGF.



A regularly update has been made every month. Many photos have been sent to illustrate the activities on the ground.

Once again, I would like to thank RSGF for its financial support that allowed me to initiate an action of integration of the communities in the protection and the management of a protected area in Burundi. This first experience is mentioned actually as an example to duplicate in other protected areas of Burundi. This is a recommendation of the Director General of the National institute for the Environment and the Conservation of the Nature in Burundi.
