To provide a unique opportunity to combine monitoring and research efforts with conservation education of visitors		X		We have successfully enhanced the interest of both the volunteer team and visitors, and established monitoring and research programme at the sanctuary. The daily visitors are of very various depth of interest. We believe that certain percentage of them leave Kuterevo with better understanding of bigger picture of bear conservation and management. The educational trail was finalised only at the last stage of the project and the long-term effect of it will be possible to assess only in the next seasons.
To complement ongoing countrywide research on large carnivores and monitoring program within management plans		X		We have established a closer cooperation between the sanctuary and the research team supervising the countrywide research on large carnivores. We were training the volunteers at the Kuterevo bear sanctuary on the methods and importance of systematic monitoring. We believe some of them took it very seriously and will certainly apply that experience later in their lives.
Education of visitors improved the understanding of the conservation issues and enhance the coexistence with large carnivores			X	We have improved the educational service at the sanctuary. This was achieved mostly by sharing knowledge while guiding visitors. The fact that so many visitors come to see bears in Kuterevo Bear Refuge raises the importance of bears in general in the minds of local people and help the conservation and coexistence. With the interviews to visitors we could see and estimate the effect of our educational efforts and how it affected their attitude. The work with the visitors also helped to create bonds between them and the people at the sanctuary, and we believe it will gain in the future.



To produce protocol for training on large carnivore monitoring	X	The protocol has been produced: a detailed version in Croatian language and the summary in English (Power Point presentation). We productively implemented this protocol in the sanctuary. The implementation will be continued with the support of the research team in next years.
Volunteers gained basic knowledge on different monitoring techniques as well as on ethology of large carnivores	X	Regular training/workshops for volunteers were organised during this project and will be continued in the future, according to protocol. We successfully involved the volunteers and obtained their support to these kinds of projects in the future. (The report on executed trainings of volunteers is attached.)

General comment: The objectives that we marked as partially achieved were assessed as such due to its long-term character. We believe that to see its real and long-term effect will be possible in next seasons. This project has lead to initiate, apply and establish the processes and activities that will be continued next years.

2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

 Unusually mild winter 2013/14 was unexpected, which influenced wolf and other large carnivore tracking in snow. Because of this we decided to focus more on transects and large carnivore signs surveys. As the monitoring activities will be continued, we will provide additional training and supervised snow tracking while appropriate winter conditions in the next season.

3. Briefly describe the three most important outcomes of your project.

- 1. Educational trail is set up in the most frequent place in the Bear Refuge and as such all visitors (more than 20,000 per year) will gain more information about bear's biology, conservation, treats, co-existence and mythology. The trail is created in an open way, what leaves space for further development and upgrading.
- 2. Educating and involving Kuterevo volunteers into monitoring of large carnivores. Long-term and short-term volunteers gained lots of new knowledge on monitoring and ethology, as well as motivation to get more involved into field work and collection of data for national monitoring programs. In the same time, volunteers acted as multipliers and messengers, through guiding visitors in the Refuge (more than 20 000 this year) and coordinating and working with other volunteers (around 300 this year)
- 3. Involvement of different groups into monitoring of large carnivores was a pilot attempt to share different viewpoints and motivations for getting involved.



4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The very fact that the village of Kuterevo hosts the Bear Sanctuary offers the opportunity to local community to market the local products (wooden and woollen handicrafts, local honey, cheese, berry products), as well as renting apartments and preparing meals. People in general have a very positive attitude towards bears and it is essential that it does not worsen. With the input from this project we believe that their eventual concerns about coexistence with bears and other large carnivores will be more properly met.

5. Are there any plans to continue this work?

- Trail to be developed and upgraded.
- Transferring knowledge and competences to new generations of volunteers in the next years they will be using the equipment bought (GPS devices, camera, and laptop) with the funds of this project and will continue monitoring presence of large carnivores in the area.
- Closer cooperation with protected areas around Kuterevo (Velebit Nature Park and National Park Northern Velebit) and with hunting right owners around Kuterevo area.

6. How do you plan to share the results of your work with others?

The results will be shared via internet tools (webpage, volunteers' blog, and newsletter) and social media. We will also use different events (workshops, exhibitions, conferences) as opportunity to share experience, results and suggestions.

- An online version of the panels will be available online on the sanctuary website as an electronic leaflet.
- Educational trail is the obvious way of sharing results, content, and information to visitors, volunteers, and school groups. The guiding tours will be focused on continuing this effort and using the trail to increase the large carnivore's awareness of visitors and improve the understanding of the conservation issues, and enhance the coexistence with large carnivores.
- Workshops and educational activities with school groups and volunteer groups will be developed based on the educational trail.

7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

RSG was used throughout the whole duration of the project of 1 year. The elements of the Educational trail were gradually installed during the whole year but the main set of panels were produced and placed at the project's end.
