**Project Update: December 2015** 

## Introduction

The project implementation started off with activities to achieve forest restoration. A number of activities have been undertaken in Masaka and Mpigi District. These communities included a number of meetings with National Forest Authority (NFA), district officials, CFM groups and community leaders.

## **Progress Activities**

Supporting the formation of environmental groups such as Mpanga Community Environmental Association (MCEA) that is currently fostering forest community work in Mpigi. For example below is the Local Government certificate which resulted from the CFM implementation

project:

She was adopted in the project in order to strengthen and enhance her field capacity.



So far four meetings have been undertaken at each CFR. However one CFM application has been prepared. The application has been sent to the Local Council (V) for approval. There after the application will be forwarded to NFA for further required procedurals and consideration.

In effort to continue with the CFM project, two proposals have been submitted. However, one of the proposals was recommended for north collaborative actions while the other is still undergoing the review.

## **Field Observations**

In central Uganda, CFM practices appears to be a standard for the good governance of forests that will ensure the management of forest-based resources which they harvest guided by the wishes of local communities.

A taxi carrying *Mundia whitei* a climber common in the tropical rain forests. It is mainly extracted from forests in Masaka Town.

M. whitei is commonly used for tooth cleaning, aphrodisiac and freshening breath.



So far the project team has observed that forests and local communities meet, by implementing a CFM standard in which they are avoid risks and generate local ownership around a wide range of forest projects and activities, including carbon trading, ecosystem services and sustainable development.
