2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

I had not anticipated that the nature clubs would require tools to prepare the tree nurseries. I had to reduce the budget to buy each school simple tools. Secondly, I had planned for 10 schools in Mathira Sub-County in Nyeri. The local leadership said we had to include the other three sub-counties of Othaya, Tetu and Kieni. This overstretched the budget and consumed a lot of time because the clubs had to be launched in each sub-county. The project now has 25 primary schools with fully functioning Environmental Clubs.

3. Briefly describe the three most important outcomes of your project.

The three most important outcomes are:



- a) Environmental Clubs have been established in 25 primary schools. Each of the schools has a tree nursery and land has been allocated in the school compound to plant the seedlings. Hence each school will have a small forest of indigenous trees.
- b) Karatina University has established collaboration with the County Government of Nyeri and the Kenya Forest Service. During the celebration of the International Day of the Forest in March, 2016, a partnership was established between the three institutions. Already Memorandum of understanding is being developed between Karatina University and Kenya Forest Services.
- c) A Tree nursery has been established in the University. This is part of the Botanical Garden which has not been completed. Fencing of the garden is yet to be done in addition to two resting sheds to be constructed.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Twenty five local primary schools have established Environmental Clubs. The local education officers now work closely with Karatina University on the project. The launching of the clubs in selected schools took the university to these schools and gave the pupils and teachers an opportunity to interact with university staff and know more about the university. In addition, patrons for the Environmental Clubs had a rare opportunity to come for a 1-day workshop in the university. They commented that they have been seeing the university from far but the project has given them the opportunity to ride in a university bus and enter the compound of the university.

5. Are there any plans to continue this work?

YES. There is monitoring and evaluation of the established clubs. Primary school head teachers who were not selected appealed to the Team Leader during the last launch that they should be considered during the next phase of the project. There are plans to established Environmental Clubs in all primary schools in Nyeri County. The project team wishes to roll out the project in all the 47 counties in Kenya. However, the immediate plan is to add two more counties after Nyeri.

6. How do you plan to share the results of your work with others?

I will present the results of this project with relevant government authorities by sending briefs to their offices. I also plan to present the results in a conference and in university seminars. Due to media coverage, the results have been shared with



Kenyans through newspaper articles (attached). I also intend to hold a meeting with the local leaders.

7. Timescale: Over what period was The Rufford Foundation grant used? How does this compare to the anticipated or actual length of the project?

The project has run for 13 months which is only one month beyond the actual length of the project.

- b) Training of the remaining patrons who did not attend the training because their schools were doing examinations so they could not make it.
- c) Development of Memorandum of Understanding with Nyeri County, Ministry of Environment, the Kenya Forest Service and the National Environmental Management Authority.
- d) Sharing results of the project with University Vice-Chancellor and other staff members in the university.

Yes, we used the logo of the RSGF at the project site, programmes for launch of the clubs, Programme of the workshop for patrons and on certificates of the patrons

It has been an interesting experience working with small schoolchildren and seeing their enthusiasm to conserve the environment. The project has given Karatina University publicity in the electronic and print media. Already the local community are aware of the project and it is the talk of schools within the county. I hope that RSGF will be able to provide additional funds for expanding the clubs to as many schools as possible. The Botanical Garden is not fully completed and I hope to receive additional grants to complete it.
