#### 3. Briefly describe the three most important outcomes of your project.

- a) Raised the public awareness of the necessity and urgency of changing the unsustainable fishing and pearl breeding practice into the sustainable fishing and breeding methods within the distribution area of the coral reefs along the western Hepu coast.
- b) Helped the local communities to establish the underwater ecological tourism industry that can bring both economical benefits and environmental benefits.
- c) The whole local communities have a strong incentive to conserve the coral reefs and their surrounding in a sustainable way.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Conservation educational materials like posters and VCD had been distributed among local communities consisting of 826 families covering fishermen and school students at all levels. Local communities will be gradually aware of the harm of their current breeding and fishing activities and learn and grasp the technology and necessity of sustainable breeding and fishing through supervised practice under the direction of my team.

With increased underwater tourism revenue from the beautiful and amazing corals and their surrounding ecological system, local fisherman are abandoning gradually their previous unsustainable methods of fishing and aquatic breeding, and replacing the old method with environmentally friendly fishing and breeding methods. The whole local communities also have a strong incentive to conserve the coral reefs and their surrounding in a sustainable way.

The results of my project work will be shared with others through the presentations on regular conservation conferences and reports by local newspaper.

**P.S.** The budget amount was calculated on the exchange rate of 9.81 Yuan/£ on application submission date with a value of 57485 Chinese Yuan, but the actual exchange rate upon the receipt of the grant was 11.12 Yuan/£ with a value of 65274 Chinese Yuan due to the appreciation of British Pound. The extra 7789 Chinese Yuan helped cover the increased actual project expenditure of £794 calculated at the original exchange rate of 9.81 Yuan/£.

Continuous on-site monitoring and investigations will be conducted to ensure that the project achievements can be long-lasting and replicated in other counties with polluted corals in Guangxi province.
