## **2.** Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

There was an extremely active hurricane season in 2010 and a high frequency of ground swells in the latter part of the year as well as so far in 2011. This has made in water surveys of the sea turtle population almost impossible. The schools calendar appeared to be fuller than normal making it difficult – in fact impossible -to arrange debates. We arranged to concentrate on quizzes instead.



#### 3. Briefly describe the three most important outcomes of your project.

(a) Recruitment and training of student volunteers. This ensured that there was a high frequency of patrols on the index beach and frequent morning patrols of the other main nesting beaches. It also meant that we were able to tag the largest number of new nesters (20) on the beach in years and encounter the second largest number (31) of turtles ever on the beach.

(b) Sea turtle camp 2010. We were able to get the message of sea turtle conservation out to many children and to parents as well. Through this programme we were also able to get much publicity in the local media.

(c) Getting members of the public, especially schoolchildren and youth groups, out to the beaches to observe sea turtle conservation work in progress. This has helped spread the conservation message throughout the island. As friends tell friends we get more and more persons involved in our conservation efforts.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Student volunteers are selected from the local community and they are gainfully occupied during their holidays as well as weekends. The small stipends help them supplement family income. In the few foraging sea turtle population surveys that we conducted fishers were able to have their fuel subsidised as they went on normal coastal fishing trips. They were grateful for that and are willing to continue assisting us in these efforts.

#### 5. Are there any plans to continue this work?

Yes we have and are indeed continuing this work. Former student volunteers have agreed to continue to work with us even though no stipend will be available this year. We plan to increase the in water surveys weather permitting.

#### 6. How do you plan to share the results of your work with others?

The information on monitoring for 2010 has already been shared with the local television audience and has been shared online via the Nevis Newscast. Some of it will be available online at <u>www.nevisturtlegroup.org</u>. The information is also shared with the Wider Caribbean Sea Turtle network and other conservation organizations in the region. This information is also shared with our local and regional radio audiences.

### 7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

The RSG was used from late April 2010 to 23<sup>rd</sup> April 2011. The project is ongoing so this RSG covers 1 year.

- 1. Continue nesting beach monitoring involving even more persons.
- 2. Tagging of the foraging sea turtle population.



- 3. Continuation of public education programme.
- 4. Working with property developers, beachfront property owners and hoteliers to lessen the impacts of beachfront development on sea turtle nesting.
- 5. Involving more young persons in sea turtle conservation.

### 10. Did you use the RSGF logo in any materials produced in relation to this project? Did the RSGF receive any publicity during the course of your work?

Yes the RSGF logo would have featured on all our calendars and we have publicised widely that we have now received two grants from the RSGF. We would have done this in all our media campaigns regarding sea turtle conservation.

#### 11. Any other comments?

We would like to express our sincerest gratitude to the RSGF for its support for sea turtle conservation on Nevis. We are hoping that this would lead to greater efforts in regards to marine conservation on our island. The project will continue and the grants have assisted us so far in building a cadre of young conservationists that can continue the conservation work into the future. We look forward to continued assistance from the RSGF in the future as we continue to build on the foundation that we have constructed so far. We have tagged the third highest number of hawksbill turtles in the eastern Caribbean after Barbados and Antigua and Barbuda that are under the aegis of the East Caribbean Sea turtle tagging programme that is based in Barbados. We are now seen return nesters from as far back as 2004. Previously a number of nesters would have been taken off the beach. The programme has thus had a positive impact. We look forward to continuing to help the sea turtles of Nevis to survive.
