2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The area is home to one of the very bad militia, leading to concerns on security. Rebel groups operating in these areas have increased the extent of trouble that accessibility to the site is now difficult. We overcame this with the implication of local chiefs and their will to assist us work as they have been implicated in these activities since the first phase of the project. This is why we could held meetings and visit schools and even conduct monitoring and sampling activities in the reserve.

3. Briefly describe the three most important outcomes of your project.

- 1. An updated list of species for bats and other mammals is provided as well as the species of conservation importance (endangered and endemics). This time, the eastern part which is the savannah was also investigated;
- 2. Apart from the local chiefs, we had meeting with the provincial minister of Environment; the conferences provided an addition to the normal sensitization meetings we had all the times.
- **3.** The Management Plan for Mount Hoyo is drafted and awaiting the approval of the ICCN main office.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

- 1. We had the implication of the provincial minister in charge of environment in our work in Mt Hoyo and he gave instructions to the Officer of Environment at Irumu Municipality to accompany us at all stages of the activities.
- 2. The local community has benefited from the workshop and the conference and accepted to send their children as rangers and also study botany, zoology and other disciplines in order to benefit from job opportunities in the reserve.
- 3. Schools have obtained posters of the bats and other mammals of the region.

5. Are there any plans to continue this work?

For the future, our plans are:

- 1. Continue the work on species composition change across the seasons, with more emphasis for the savannah part of the reserve.
- 2. Continue to record the species occurring in the reserve as well as training rangers on species identification.
- 3. Add new students from Shalom University to work on bats that can continue to work with rangers on monitoring the bat populations.
- 4. Get the Management Plan from ICCN/ Kinshasa and work for its implementation.

- 1. A report of this project will be sent to ICCN.
- 2. Provide the updated species lists to ICCN as well as the scientific community.
- 3. Data for Mt Hoyo will be added in the Project of the eastern DR Congo Atlas being drafted.

9. Looking ahead, what do you feel are the important next steps?

More efforts are needed to collect additional data since more caves have been found in the vicinity of Mt Hoyo what harbour more bats. With the implication of the



provincial government through the Minister of Environment, we intend to work with stakeholders in order to improve the conservation activities in the reserve.

10. Did you use The Rufford Foundation logo in any materials produced in relation to this project? Did the RSGF receive any publicity during the course of your work?

Rufford logo was used in the poster that was made to be distributed in schools surrounding the reserve as well as in both North and South Kivu provinces (included in this report). It was also used in the conference and meetings advertisement and invitations and the conference slides.

11. Any other comments?

Globally, all the activities took place nicely. For some activities, the amount from the budget was short while for others did not take as much as budgeted, which did compensate. The supplement from CRSN helped finalise the work.

There is much to do at Mt Hoyo and ICCN is very happy with the data our group is providing. The document of the management plan was drafted and sent to ICCN.

We hope that it will be approved and implemented soon.
