I haven't faced any unforeseen difficulties during the project duration.

#### 3. Briefly describe the three most important outcomes of your project.

- Most important ecosystem services offered by Banke National Park have been explored. In particular, separate analysis carried out for cultivated goods, harvested wild goods, water related services, and nature based recreation and tourism.
- Present status of ecosystem services and their temporal variation have been determined. The drivers of change in ecosystem services have also been identified.
- Awareness has been raised among local communities as well as school children for Chure ecosystem conservation.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

This project made success by the strong support from local communities. Community forestry user groups were involved in different stages of the project. For example, local people were enthusiastically participated in awareness campaign, supported in field inventory/mapping, and provided required information during household questionnaire survey. About 60 local communities and 50 school students



directly benefitted from the awareness programme. In addition, involvement of local communities in the field assessment of ecosystem services can be regarded as the sustainable impact of this project in conservation of Chure ecosystem.

#### 5. Are there any plans to continue this work?

I am planning to continue this project by emphasising assessment of ecosystem services in buffer zone areas along the corridor of Banke and Bardia National Parks that lies in Chure region. These corridors are most important for the movement of wildlife, and provide the essential ecosystem services.

#### 6. How do you plan to share the results of your work with others?

I have been analysing and writing report of this project, and expected to finish by next 6 months. I am writing this as a manuscript to be submitted to an international journal for review and publication. I will also share the results of this project in national and international conferences. In addition, major findings of this study will be made available to the national newspapers.
