2. Please explain any unforeseen difficulties that arose during the project and how these were tackled.

Fortunately, there was not any such difficulties.

3. Briefly describe the three most important outcomes of your project.

- Full inventory of all white stork nests made for the first time in Kosovo resulting in presence of 86 nests,
- The establishment of cooperation between the two main relevant institutions in the field of white stork management (Ministry of Environment and Electrical Distribution Company - KEDS) by erecting, for the first time in Kosovo the platforms for some white stork nests,



• Raising awareness of the local communities for the importance of coexistence with white stork.

4. Briefly describe the involvement of local communities and how they have benefitted from the project.

The local community was one the main partner in order to successfully implement our project activities. Their involvement through direct meetings and communication was very important in order to get as much as possible the relevant data about the phenology of the white stork and all other relevant data related to white stork activities from their arriving until their departure/ migration.

Residents addressed to us the new information from the field and they directly helped us in locating some of the nests.

The local community benefited in the form of education that they were given from as through brochures, discussions and giving messages for importance of preserving the living habitat for this protected species. Most of them didn't have neither elementary information about the stork biology and the importance of their protection.

5. Are there any plans to continue this work?

Since we have established now the monitoring plan by collecting for the first time very important data about the Kosovo white stork biology and ecology, we will continue to collect the information each year in order to have the possibility to compare and analyse those data for many years.

The started activity with nest platforms will continue since we have got the promise of both institutions to build such platforms for every necessary nests with financial assistance of Kosovo Electrical Distribution Company-KEDS.

We plan also to continue with promoting and raising awareness among local population about the importance of biodiversity conservation with special attention on the development of bird watching.

6. How do you plan to share the results of your work with others?

Since we had been obliged to get the permit from the Ministry of Environment and Spatial Planning of Kosovo to realise such project with a protected species such as white stork, we are obliged to prepare a report for the Ministry until the end of this year where will be specified all the activities and results realised within this project. Articles highlighting the main findings of this study would be sent to peer-reviewed and popular journals to reach a wider global audience where the contribution of Rufford Foundation will always be mention.



7. Timescale: Over what period was the grant used? How does this compare to the anticipated or actual length of the project?

The period foreseen for this project has been designed from March – September 2018 but since the decision to support the project has been taken in July 2018 we have been pushed to extend the project activities also in 2019 in order to cover the main period of white stork phenology and also to continue with such activities until the August 2019!
