Theoretical education				We managed to hold the education sessions as we planned, despite the COVID 19 pandemic. We were trying to give lessons outside as much as possible. Our all actions were in accordance with the current COVID 19 measures.

**2. Please explain any unforeseen difficulties that arose during the project and how these were tackled.**

Although we managed to fulfil the main aim of this project, non-formal education, we believe that more people would attend our education courses if the Covid situation was better. However, we became recognizable with our attempts to make the first steps in the wildcat monitoring and conservation, and we strongly believe that more and more people will give their contributions to these actions over the time and in the further project stages.

**3. Briefly describe the three most important outcomes of your project.**

1. Education – we managed to educate the local community members, through non-formal lessons and courses, about conservation in general, the presence of wildcats in our local community, their appearance and behaviour, and the main threats jeopardising their existence. The particular significance of this outcome is in the diversity of the local community members that were educated.

2. Coexisting – we educated local community members on how to co-exist with wildcats and therefore increased the chance for the long-term maintenance of wildcats in our community.

3. Database – we initiated the database that includes all important information about the wildcats (e.g., presence, abundance, photos, dead cases from various reasons, etc.) not just in our local community but in the other communities as well. In this way we started with the networking of people having similar ideas about the conservation of wildcats across Bosnia and Herzegovina.

**4. Briefly describe the involvement of local communities and how they have benefitted from the project.**

The local community was fully involved in this project by attending education sessions and being involved in the field activities. As planned, we educated various local community categories about the presence and importance of the wildcats (using tools according to the specific age/category). The main benefit for our local community was in understanding the wildcat presence in our municipality. Many people were totally surprised knowing that we share our habitat with the wildcats. People attending our education sessions didn't know what wildcats look like and how to differentiate them (morphologically) from domestic cats. By addressing these uncertainties, both, local community and wildcats can only benefit. Conservation of the wild animals is one of the most popular topics and most needed actions in the wild animal preservation across the world and hugely important in Bosnia and Herzegovina, one of the countries with very rich biodiversity and a high rate of endemism.

**5. Are there any plans to continue this work?**

We definitely plan to continue our work. In the next stages of the project, we plan to expand the area of the monitoring and non-formal education about wildcats. The other municipalities settled next to the river Sava, eastward Srbac, are also inhabited by wildcats. As this pioneering project showed success and raised the interest of our local community about wildcats, we expect the same in the other local communities.

**6. How do you plan to share the results of your work with others?**

We will share our results by: i) informing local and national medias about our project, ii) organising and attending seminars and conferences where we will present our project, and iii) publishing papers when collecting enough of data.

**7. Timescale: Over what period was the grant used? How does this compare to the anticipated or actual length of the project?**

The grant was used over the period of 12 months, 2 months longer then was proposed by project. Although our project is finished, we will continue with the monitoring using photo-traps that we bought within the project budget and with the

help of the local hunters that will place them according to the sign of the wildcat presence.
