Facilitate stakeholders' forum				We increased the spectrum of stakeholders' interest and involvement in the project by facilitating a workshop that included the executive, legislative and judiciary arms of government including all security agencies, while also increasing participation of members of community by involving various groups in the community in workshop.
We will invest in human and social capital so that there are improved benefits for local communities in conservation				We implemented various livelihood projects from providing capital/equipment for small businesses, livestock production and trainings. We were unable to provide the fuel-efficient stoves as the results of NEEDS assessment indicated that there was minimal use of firewood in Ise community, so we scaled up efforts in alternative livelihood programme which is still ongoing.
We are increasing efforts in public education/ enlightenment/ outreach on conservation issues that will both provide better access to information on the conservation activities being implemented and also increase local knowledge of the species and support for conservation				We instituted conservation education programme in 24 community and public schools using tailored curriculum. We also erected billboards and had messages aired on radio channels popular in the community and neighbouring urban/sub-urban areas.
Coordinate rangers' antipoaching patrols and collect more species-specific data that will increase scientific knowledge of this distinct group of chimpanzees				There were 315 patrol days in 12 calendar months reducing threats to wildlife and forest by 95%.



#### 2. Describe the three most important outcomes of your project.

- **a).** Significantly increase protection for chimpanzee and other wildlife, as well as for the of Ise forest.
- **b).** Increased stakeholders' interest/participation in forest and wildlife conservation.
- c). Provided benefit for local stakeholders linked to conservation efforts.

## 3. Explain any unforeseen difficulties that arose during the project and how these were tackled.

One major unforeseen difficulty the threats to life posed by marijuana planters. This problem was tackled by a close collaboration with government authorities especially with the exceptional support of the State Governor – His Excellency Dr. Fayemi.

## 4. Describe the involvement of local communities and how they have benefitted from the project.

The communities are practically involved in the project, firstly, by recruiting 98% of staff from the community and also by making regular reports to the council of elders quarterly. When problems are encountered, the community leaders were relied on for support, collaboration and advice in tackling the problem. Benefits accrue to the community in livelihood programmes, conservation education and even varying level scholarships to 550 children in the community.

#### 5. Are there any plans to continue this work?

This work is an ongoing effort, and we just entered the  $2^{nd}$  year of a 5-year management agreement with the Ekiti State Government. Even though, a new governorship administration is about to commence, we believe that there will be continuity and that the incoming administration will not only respect the agreement but also support the project in all ramifications.

#### 6. How do you plan to share the results of your work with others?

We are doing presentations of our work at every level, with local stakeholders and at international level. We have just recently presented the results of our work at the inaugural IUCN African Protected Areas Congress (APAC) in Rwanda in July 2022. We hope that the results of our work will form part of a new paper we are writing on primate conservation in Nigeria.

#### 7. Looking ahead, what do you feel are the important next steps?

The most important next step is ensuring project sustainability.
