2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The main difficulty was the prolonged drought that gripped the country through the better part of 2008. There was also a problem of high bamboo prices and the unavailability of adequate number of bamboo seedlings.

3. Briefly describe the three most important outcomes of your project.

The most important outcomes are as follows:

- I have managed to increase the tree biodiversity of the wetland by more than 30 species that were hitherto not there.
- I have raised awareness of the community culminating in the formation of a communitybased organisation, the Friends of Ondiri Wetland Conservation (FOWCON).
- I have managed to bring together various stakeholders of the wetland and as FOWCON we have managed to put together a comprehensive proposal for funding which we hope to take to various funding organisations.

4. Briefly describe the involvement of local communities and how they have benefited from the project (if relevant).

The local communities have benefited immensely from the project. Their knowledge of conservation has been enhanced. Women's groups have benefited by selling tree seedlings to the project while the Kenya Forestry Research Institute has benefited by supplying bamboo. Riparian owners have benefited by planting trees and bamboo in their frontage which will prevent soil erosion in future while school children have also learnt about the benefits of conservation.

5. Are there any plans to continue this work?

Yes. A comprehensive proposal has been written and I am also intending to apply for a second RSG grant to get the project to the next level.



6. How do you plan to share the results of your work with others?

I am planning to start publishing a monthly newsletter that will highlight the development of the project and the evolution of Ondiri Swamp into a fully-fledged community ecotourism facility.

7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

The RSG was used over a period of 18 months. I feel that this stretched the time and one year was enough to undertake all the planned activities.

- ✓ Develop a conservation training and reference manual for capacity building for all riparian owners and other stakeholders.
