Project Update: April 2023

1. Summary of activities carried out in the first year

1.1 Study areas selection

During the first stage of the project, the selection of possible study areas was carried out based on the search for stingless beekeepers in the city of São Paulo, by establishing contact, establishing partnerships, visiting meliponary farms and mapping the locations. The 15 locations (Figure 1) that represented the best spatial representation of the city were selected, that is, the points were well distributed in neighborhoods across all zones of the municipality - North (ZN), South (ZS), East (ZE), West (ZW) and Center. To facilitate the layout, the areas were abbreviated as M (meliponary) and ordered from 1 to 15.

1.2 Pilot experiments

Three study areas were selected to carry out the pilot experiments (M03, M04 and M05). There was variation between the study areas, showing that the release and monitoring methodology can be used in urban areas. To be able to infer whether the variations between the coverage regions occurred due to the landscape around the nests and not to other factors, it is necessary to repeat the experiment with a larger number of study areas, and a greater distribution of release points and distances, to cover a better representation of the landscape around the meliponary. Thus, the pilot study provided the necessary subsidies for the development of the present project proposal, and based on these observations, the experimental design was redesigned. The results of the pilot experiments were consistent and enabled the publication of a scientific article in Frontiers in Sustainable Cities magazine, special edition World Bee Day 2022: Pollinators in Urban Environments. This article was presented in the Qualifying Exam on 03/30/2023, with Approved result.

1.3 Field experiments

After the confirmations obtained through the pilot experiment, the sample design of the bee release points was organised and the experimental stage of the project began, including the marking, release and monitoring of the bees and the honey collection.

1.1.3 Experimental design

The experimental design was improved according to the considerations of partner researchers and considering the results obtained in the pilot experiment. Data collection in the field was carried out in 15 meliponaries located in the city of São Paulo, and in each one a nest of *Melipona quadrifasciata* was selected for carrying out the experiments, prioritizing hives classified as healthy by their respective stingless beekeepers.

The surroundings of each meliponary were divided into three coverage regions from generated buffers, with the colony as the central point: 300, 600 and 900 m. The coverage regions were organised into subdivisions of 20 m, which served as a guide for the release of the bees. Additionally, for each meliponary, the 900 m coverage region was divided into nine 40° sections (Figure 2).

During the period of 6 months (spring and summer), for each meliponary, three collections and releases of 45 bees (n=135) were carried out, in non-simultaneous experiments (only one place per day). Considering that the peak of *M. quadrifasciata* foraging activities occurs until 10:00 am, the release of bees from each nest was carried out on the same day of collection, on sunny days or with low cloudiness, between 08:00 and 09:00. The first release stage (November and December) was carried out in sections 1, 2 and 3, the second release (January and February) in sections 4, 5 and 6 and the third (March and April) were carried out in sections 7, 8 and 9 (blue lines, Figure 2).

For each meliponary, the bees were randomly divided into nine tubes, each with five individuals. A coloured marking was assigned to each tube, from which the bees were marked with a non-toxic water-based pen of different colours (Figures 3 and 4). These tubes were grouped into three groups, each with three tubes, so that bees from three groups (15 individuals) were released within the 300 m coverage region (red lines, Figure 2) - Points (P) 1, 2 and 3 -, others of three groups in the region of 300 to 600 m - P4, P5 and P6 - and finally, others of three groups between 600 and 900 m - P7, P8 and P9.

The release section for each group was randomised. For the release of bees within the groups, first a distance was drawn considering the 20 m subdivisions (black lines, Figure 2) as a reference, and the other two releases were made considering 100 m of distance in relation to the first draw. For example, in Figure 5, for the first group (0 to 300 m – points 1, 2 and 3 in pink) the third section (rays in blue) and the distance of 60 m were drawn; thus, releases were performed at 60 (point 1, pink), 160 (point 2, pink) and 260 m (point 3, pink). For the fourth group (0 to 300 m, points 1, 2 and 3 in blue) the sixth section and the distance of 20 m were drawn; thus, releases were performed at 20 (point 1, blue), 120 (point 2, blue) and 220 m (point 3, blue).

1.1.4 Data collection

Video monitoring was carried out to obtain the returning times of bees to the hive (Figure 6A and B). After the release of the last group of bees, the recording was performed for 3 hours, a period that was established from the pilot experiment, as the interval that the bees need to return to the meliponary. Currently, we have just finished the third stage of release (March and April) of field experiments, together with honey collection (Figure 6C).

I participated as a debater at the 13th Congress of Initiation in Technological Development and Innovation, 28th Congress of Scientific Initiation in High School at the Federal University of São Carlos.

4. Plan of activities for the next periods

In the next stage we will begin the analysis of the data obtained during the field data, including the analysis of the videos to obtain the displacement times of the bees and the analysis of the collected honey.
