We are using the mini zoo for environmental education programs with children from the camp nearest to the house and surrounding schools

The problem was presented to the government and many actions were undertaken. A control program was set up by the Inspection Department of the Ministry of environment of Cuba. The current world economic crisis restricted access to many items or increased their price. Hurricane lke hit Cuba close to Gibara village, destroying surrounding coastal areas and damaging a great part of the buildings.

The local communities were including in any action through the communitarian festival "Protegiendo las Aves", especially the younger generation. Two protected areas were approved and right now Gibara is considered as an IBA site by Birdlife International, creating new jobs among the local people that will be involved in conservation efforts.
