## 2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

We have not any unforeseen difficulties that arose during the project.

#### 3. Briefly describe the three most important outcomes of your project.

- Determined list of medicinal plants in project's area with 412 species belonging to 81 families, amongst them 13 are endangered species.
- Collected information (experiences, remedies) on ethnic medical knowledge of Tay Nung People. They are basic in order to conserve and develop traditional medicinal plants in future.
- In part, enhanced aware of local people in conservation and sustainable use for medicinal plants.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Local communities have participated willingly in the project. As a result, they have idea about economic value of ethnic medicine (medical plants, knowledge) from project.



#### 5. Are there any plans to continue this work?

In next time we have more ambitions to continue following works:

- To research to establish conservation model of medical plants in community.
- To study on multiplication (sexual or asexual) of rare and endangered medical plants for conservation and development.
- Research into changing traditional medical plants and ethnic remedies into commercial products in order to increase income for local people.
- To publish a monograph *Traditional Medical Plants of Tay and Nung People* in local language (according to the requirement of local people).

#### 6. How do you plan to share the results of your work with others?

The results of the project were reported in the conference *Traditional Medicinal Plant Conservation of Ethnic Minorities* organized by Vietnam National Museum of Nature in Lang Son Province in 2008.

These results will be presented at the conference *Conservation of Traditional Medical Plant Sources* to be held by Institute of Medicine Materials in Bach Ma National Park in October 2009.

## 7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?

In fact, identification of medicinal plants has been lengthened to first months of 2009. Some specimens could not be indentified in 2008 according to project's plan.
