1. INTRODUCTION

This June, the following field activities, related outcomes, discoveries, interventions, and incidents were noted by field and secretariat staff.

Interventions

• Tree planting and reforestation activities.

Discoveries and observations

- Elephant mortality (natural)
- Illegal logging activities in the National Reserve
- Snares, poacher signs, poacher hideouts and related incidents
- Other illegal activities in the National Reserve including, grazing and charcoal burning
- Other wildlife related mortalities and observations
- Arrests and apprehensions.

Activities

• Drills for field based scouts.

1.1 Programme patrol and field activity intervention sites (June 2014)

Project activity areas patrolled by field based teams this June:

- Elephant Corridor Team Elephant Corridor and the immediate Corridor precincts'
- Marania Wildlife Guards Mlima Dinga, Upper Corridor, Mlima Nyeusi, Rutundu, Daraja ya Charlie, Uwanja ya Dyer and Marania Forest
- Horse Patrol Team (HPT) Marania River, Mlima Ngaita, Solo Camp area, Emburi Forest, Karuri Forest, and Wangu /Emburi farm boundary area
- Joint Wildlife Protection Team (JWPT) Ruthumbi area and parts of immediate adjoining vicinity
- Tree planting and fencing initiatives Karuri area of the Ontulili forest block
- Drills Kisima Farm Airstrip.

2. PROJECT UPDATES

2.1 Tree planting and reforestation activities

More seedlings are expected to be nurtured by the Gatinka Tumaini Women Group in readiness for the next planting season in the Karuri area of Ontulili Forest block later this year. This follows a site

visit by the Trust's field coordinator and relocation to a new expansive tree planting site by group members. The area has been allocated by the KFS to the women group at an annual subsidized yearly rent of Kshs. 2,500. MKT's support to this group includes provision of fencing materials, the purchase of tree nursery equipment and a water tank. This expansive nursery area will be used ostensibly towards raising seedlings supported through an annual donation by Safarilink⁸. Group members gathered and relocated all scattered tree seedlings to the new site using the

Trust's field vehicle. The Trust's field coordinator also used the occasion to present group members with a cheque for the previous planting season work.

2.2 Field training for scouts

As part of ongoing capacity building efforts, all field based MKT teams underwent a day's drill exercise and training at the Kisima Farm Airstrip on the 6th of June. The training was geared at making the consolidated MKT team active whenever they are on patrols and also instill discipline,

cohesion and respect amongst team members. It also served as an occasion to interact and exchange experiences and lessons learnt by members of the various teams. The training was facilitated in-house by MKT and conducted by the Trust's northern sector supervisor, Mr. Maurice Thure who has a background from the Kenya Police force. The more recent recruits and younger members of the teams found the exercise particularly useful. Similar exercises are planned for later in the year.



2.3 Elephant mortality incidents

At least one Elephant (*Loxodonta africana africana*)⁹ was found to have died of natural causes on the northern section of Mount Kenya this June. The discovery was made following intelligence leads by



members of the public on the 11th of June. The Marania Wildlife Guards, received information of an Elephant carcass in the lower Mlima Dinga Area. The male Elephant was estimated at 45-50 years and was found while team members were patrolling the area from Rutundu to Marania at about 1630hrs. The carcass was fresh and the cause of death was natural; the carcass lay on the fringes of a flowing stream. KWS Marania field station were immediately contacted and managed to mobilize a team and retrieve the tusks each weighing 41Kg.

2.4 Illegal logging within the National Reserve /Forest Reserve

The above incidents were recorded by the Elephant Corridor Team and the JWPT this June. These cases are tabulated in chronological order below:

2.8 Arrests and apprehensions

The following is a chronology of an arrest made this June:

Three (3) logging suspects: Mbijiwe Kanampiu, Charles Mwirigi M'Irithe and Samson Muriuki Mbui were on the 7th of June arrested while in the process of milling timber from illegally logged Podo (*Podocarpus spp.*) trees within the protected area of the National Reserve. The JWPT handed them over to Nkubu Police station where charges were conferred on the three OB: No. 41/07/06/2014. Exhibits relating to the crime were also presented to the Police including a chain saw, 2 jerricans full of petrol, a jerrican of oil and two (2) Podo beams.
