MONTHLY PROGRAMME ACTIVITY REPORT

MARCH 2014

SUMMARY

The onset of the heavy rains in late March signaled the start of the Trust's tree planting activities for year 2014. Other field interventions made by field and secretariat staff remained ongoing as highlighted below:

- Tree planting and reforestation
- Environmental education and awareness
- The Joint Wildlife Protection Team
- Marania Wildlife Guards
- The Horse Patrol Team
- The Elephant Corridor Team
- Meetings and workshops

The report covers MKT activities for the period 28th February 2014 to 31st March 2014. The following field teams provided updates: Marania Wildlife Guards¹; the Elephant Corridor Team², the Horse Patrol Team³ as well as reports by the northern area supervisor on matters related to the northern sector project areas. In the eastern section of the mountain in Ruthumbi, field updates were collated by the Joint Wildlife Protection Team4 under the leadership of the Senior Wildlife Community Officer. Humphrey Munene⁵ provided updates on tree planting, education and awareness. The report for March 2014 was compiled by Maurice Onyino Nyaligu⁶.

1. Introduction

The following are field activities, related outcomes, discoveries and interventions undertaken and observed by field and secretariat staff during the month of March.

Interventions

- Tree planting and reforestation activities
- Education and awareness outreach initiatives
- Consultative meeting by the Elephant Corridor stakeholders
- Laikipia wildlife security task force meeting
- Fire fighting

Discoveries and observations

- Illegal logging and bamboo harvesting within the National Reserve /Forest Reserve

1.1 Programme patrol and field activity intervention areas

Project activity areas patrolled by field based teams this March are:

- Elephant Corridor Team Elephant Corridor and the immediate Corridor precincts'
- Marania Wildlife Guards Marania forest, Emburi area, Kisima forest, Kimbo area, Kiwanja ya Dyer, Daraja ya Charlie, Chemi chemi ya Ndovu, Elephant Corridor, Mlima Dinga, Mlima Suruai and Mlima Suruwa areas within the Protected Area of the National Reserve
- Horse Patrol Team (HPT) Marania forest, Marania river, Solo camp area, Kisima area, Emburi area, Karoli area, School of adventure, Mlima Ngaita and Kiwanja ya Dyer areas within the Protected Area of the National Reserve
- Joint Wildlife Protection Team (JWPT) Ruthumbi area and parts of immediate adjoining vicinity
- Environmental education and awareness initiatives Primary and secondary schools within Embu County

2. Project updates

2.1 Tree planting and reforestation activities

This March, a site assessment of ongoing reforestation in the Karuri block of the Ontulili Forest was undertaken. Reforestation activities under the Plantation Establishment Livelihood System (PELIS) have been in place since late 2012 and approximately 40,000 indigenous tree seedlings have now been planted. Planting occurs in allotted areas where KFS permits adjoining community members within the CFA framework to cultivate forest land and plant food crops alongside tree seedlings. A recent site visit to the area revealed the planting initiative as having a high chance of success



although a number of challenges and impediments will need to be addressed. Many farmers for instance were found to have neglected their obligations and as a consequence, a number of seedlings planted during the last planting season dried up in part due to farmers' negligence especially during the potato harvesting period. At the community farmers meeting, it was resolved that any farmer working on a plot found with dried tree seedlings will be forced to replace the seedlings at his own cost or alternatively risk his plot being allotted to an alternative farmer. In addition, the area designated for planting has been zoned by the KFS into two one section will be planted with exotic tree seedlings under the KFS PELIS program while the other zone will reforested with indigenous tree seedlings under the MKT/KFS and Community partnership arrangement. This season planting activities will concentrate on replacing dried seedlings in previously planted areas and partial planting on a newly cultivated sector.

2.2 Education and awareness outreach initiatives

The school education and awareness programme that began earlier in the year continued in Embu County's drier parts areas. A total of six schools were sensitized and a message on poaching and its impact on wildlife and the country's economy promulgated to school pupils. The schools visited were all in the Ishiara area of the County where cases of wildlife poaching and conflict go



unreported because of a lack of awareness amongst community members. Poaching of small antelopes for game meat and snakes particularly Pythons (which are abundant in the area) for their skins is widespread and common within the locality. Charcoal burning is also widespread as an activity and contributes to the fast disappearance of lowland tree cover and therefore increasing the rate of soil erosion, land degradation and significantly affecting the rainfall pattern at a localized level. If not mitigated, this activity is likely to further degrade the water retention capacity of the area. All school outreach initiatives were conducted in

partnership with and based on a request by the KWS Embu Station Warden. The KWS Warden explained to the audiences the institution's mandate in wildlife conservation and community social responsibility. He also elaborated on the new Wildlife Act of 2013 highlighting aspects related to the penalties imposed on poaching suspects and the compensation scheme as outlined in the Act. The Trust's officer gave a short talk on climate change and its effect on human welfare. Approximately 1,500 pupils from various schools were reached with the conservation message during the outreach initiative.

2.3 Consultative meeting by the Elephant Corridor stakeholders

A consultative meeting of Elephant Corridor stakeholders took place at Kisima farm boardroom on the 14th of March 2014. The meeting was called to discuss amongst other issues a request by the UNESCO World Heritage Committee and the Advisory Body to the Convention (IUCN) to include the Elephant Corridor as part of the core of the World Heritage property as opposed to its current status as a buffer zone. In discussion too, were implications such boundary changes would have on the land owners and legal status of the Corridor. The IUCN has already considered the protection and boundary status of the property as meeting the requirements set out in the Operational Guidelines to the Convention. Representatives from the National Museums of Kenya, KWS HQ and KWS MKNP, Lewa Wildlife Conservancy, Kisima and Marania farm establishments were all present. The request was made purely to enhance the overall status of the World Heritage Site as

well as ongoing and long-term conservation activities at the property. The Trust was represented by Susie Weeks and Maurice Nyaligu.

2.4 Laikipia wildlife security task force meeting

The Trust was invited to participate in a countrywide task force meeting set up by the Government

to review the state of the nation's wildlife security. The meeting took place on the 29th of March at the Sportmans' Arms hotel in Nanyuki. MKT was represented by Susie Weeks. The task force came about as a result of a surprise and much applauded move by the Cabinet Secretary responsible for wildlife to look into wildlife security in Kenya and will continue to solicit views from the general public throughout the country. This is yet another major initiative



aimed at transforming Kenya's success in combating poaching and trafficking of wildlife that continues to threaten the country's economy, security, tourism industry, jobs, communities as well as heritage and global reputation.

2.5 Fire fighting

As is now become the norm at around this time of the year, wild forest fires and related incidents were reported by two of the northern based field teams this March as elaborated below:

• 4th March (0725hrs and 0910hrs) - the Marania wildlife guards join the horse patrol team, KWS, KFS and surrounding community in fighting two resurgent bush fires in Marania forest around



Emburi area along waypoints 37N 0317007, UTM 0002823 and 37N 0317169, UTM 0002947. The fire started on 2nd of March but was reported the following day in the afternoon, investigations revealed the fire to have been started by illegal honey harvesters who after

harvesting honey failed to extinguish a fire on the trunk of a Rosewood (Hagenia abyssinica) tree. The joint teams fought the fire



which had already burnt about 40 hectares of mixed forest comprising of rosewood, cypress and other shrubs and manage to arrest the situation.

2.6 Illegal logging and bamboo harvesting within the National Reserve /Forest Reserve

Illegal logging activities were reported by the Joint Wildlife Protection Team and the Marania Wildlife Guards. These incidents are tabulated in chronological order below:

2.8 Damage to forest vegetation by elephants

As with previous months, elephants continue to be observed destroying trees within a section of the forest particularly within the northern section as elaborated below.

- On 3rd March (1122hrs) the Marania Wildlife Guards while on patrol within Marania forest along waypoint 37N 0325787, UTM 0007055 came across an area where elephants had destroyed several eucalyptus (*Eucalyptus spp.*) trees by uprooting and felling them down
- On 2nd March (1000hrs) the Horse Patrol Team while on patrol along River Marania encountered an adult female elephant with its young breaking down unidentified indigenous trees along waypoint 37N 0323978, UTM 0006205



- On 8th March (1030hrs) the Horse Patrol Team while patrolling along River Marania came across a section of the forest habitat where the vegetation had been significantly uprooted as a result of elephant activities on trees and shrubs along waypoint 37N 0325546, UTM 0007342
- On 10th March (1010hrs) members of the Horse Patrol Team came across a lone elephant breaking down trees in Marania forest along waypoint 37N 0326804, UTM 0007619.

2.9 Elephant corridor fence intrusion, manipulation and destruction

The following is a chronology of events pertaining to fence manipulation, intrusion and destruction along the Elephant Corridor during the month of March.

- On 8th March (1830hrs) the Corridor fencer at the lower corridor sighted three women and one man collecting firewood after manipulating the fence line. The suspects managed to escape after noticing the fencer approach
- On 10th March (1432hrs) one male suspect in the Corridor seen cutting a blue gum tree that had been felled by an elephant but managed to escape as the fencer approached
- On 11th March (0611) the fencer at Marania Corridor found the hanging wires along the fence line on the Ntirimiti rural road had been pulled down by a passing lorry affecting the flow of power. Immediate repairs were undertaken with help from Marania farm and MKT fencers and all is well
- On 17th March at about 0627hrs the fencer at Marania Corridor area came across a huge branch hanging on the fence wire after being placed by an elephant causing power shirtfalls but repairs were implemented and the system is now functional

- On 24th March (1815hrs) four suspects escape after being spotted by an MKT fencer along the lower Corridor
- On 27th March (0703hrs) the fencer at Kamiti Corridor came across a section where heavy rains had swept away the fence chain link mesh and placed huge logs along the fence. Team member managed to clear and repair accordingly and restore fence integrity.

2.11 Littering in the National Reserve / Forest Reserve



On 27th March (1530hrs) - the Marania Wildlife Guards while patrolling in Kisima forest came across a site where littering of plastic containers, nylon bags and tins had taken place along waypoint 37N 0322733,

UTM 0006102. Within the same vicinity team members came across Zebra droppings containing nylon paper (suggesting that such garbage goes a long way within the food chain of many



animals). It is suspected that the littering is as a result of several disciplined forces (local and foreign) training in the forest locality and they leave behind all the litters without burning.
