Achievements include: Conducting training: bird survey, birdwatching technique, regulation, national park management, conservation education principles. Strengthen local bird institution: established statuta of Kerinci Birdwatching Club Involving on project team: School Visit, Bird Biodiversity Survey, Market survey and Poaching Investigation, Community Meeting. Market survey	v	This survey has been identified 7 shops which sell birds (which almost all are captured from wild) and investigating excellent result. It has gathered a list of bird seek for sells and identified the volume of selling. This survey also found that some endemic, vulnerable and near threatened bird is freely sold on market for local need as well as transport to main market in other location such as Jakarta, Medan, Pekanbaru, Jambi, and Bukittinggi.
Poaching investigation	v	This investigation conducted through gathering information from several sources such as ranger, poacher, bird shop owner and bird lover. It has identified poaching location and poaching method.
Community meeting	v	This activities was conducted through door to door method to bird/ pet shop owner and buyer informing the government regulation and raising awareness to reduce capture of wild bird from the forest. The project also emphasized that poaching any birds from the national park is prohibited.
Producing and disseminating campaign materials	v	This activity produced several campaign material such as key holder, pin, poster, leaflet, local bird bulletin (bulletin KBC), and website.
Educational materials	v	binocular, research guide and printing list of protected bird and regulation.
Game	v	As part of campaign the project partially funded the successful Mural Competition of Bird Conservation 2012 conducted by Kerinci Birdwatching Club. It gained wide



attention from community. The event also supported by local government of Kabupaten Kerinci and Kota Sungai Penuh, KSNP authority, Fauna & Flora
International, and local bussinesman.

2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

In general the project did not encounter any unforeseen difficulties during conducting the activities, however it was a challenge to carry the project since in people perception, bird is utilized as pet, for example birdwatching activities as part of bird conservation and education program to some people mislead to singing bird hobbies, but by means of intensive information dissemination, campaign, field activities and school visit more people and communities are knowledgeable and aware about this matter.

3. Briefly describe the three most important outcomes of your project.

Strengthening local capacity

This is very important start on this project as the success of building local foundation to address the increasingly chronic pressure on bird habitat and population is the success of building local capacity. The project successfully strengthening local birdclub Kerinci Birdwatching Club to conduct the project activities, this also includes strengthening the organization structure and setting annual/ regular program and activities.

Bird biodiversity and distribution

By gathering researcher from universities supported by national park authority, the project able to gain important data on bird biodiversity and mapping the distribution. This will be the basis for future monitoring as well as updating existing bird database. Activities includes:

- Camera trap survey in Mount Kerinci searching for *Pitta schneider*. Result: captured the first motion picture of the bird. Conducted by KSNP staf and Kerinci Birdwatching Club.

- Identification of hornbill's food/ diet in Muara Emat. Conducted by Shaim Basyari, University student.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The project fully involves local communities in the project activities through the involvement of the local bird club member as the team on the project. They have benefitted from the project by means increasing their knowledge, able to continue/ sustain the project activities through the club annual program, more opportunity/ connections by support from local authority. The club now has strong relationship with local government and some programs will be projected to be conducted by the club. Some club member also hired by local and international NGO to conduct survey of biodiversity. This achievement will definitely inspired other to intensively involve and learn on conservation knowledge especially bird. It is a challenge for the project to introduce conservation related knowledge since there is poor emphasize from the local education institution on this subject.



5. Are there any plans to continue this work?

Yes, the next step of the project will continue some activities from previous project such as bird survey, school visit, market survey, poaching investigation, training and campaign. In addition we will conduct workshop and making guide book for educator and interpreter as well as initiate interpretation trails. We will also emphasize the need to reduce wild bird poaching in project area by means intensive news on media and/or conducting seminar/ workshop on wild bird poaching. All of these activities will involve the local bird club member and student.

6. How do you plan to share the results of your work with others?

Through RSG website, Kerinci Birdwatching Club Website, Bulletin KBC, News Paper, workshop and book.

Also conducting intensive campaign on media and/or conducting seminar/ workshop on wild bird poaching.

Yes, absolutely. Publicity through local news paper, social media and club blog.

11. Any other comments?

Young generation are the important part of the project, through the birding club and nature lover club and school they will be the agent of pro for bird conservation. Involving researcher from university student on the bird survey ensure the validity of the result as well as transforming the knowledge to the local club member. The local foundation is built significantly by means more people involve in the bird club activities, more people aware of the function of the wild bird in ecosystem, more school visited regularly annually and introduced the bird conservation educational material in the school curriculum, and more research on bird conducted in the area, also decreasing the rate of wild bird selling in the market until there is no wild bird sells in market followed by more people eager to build breeding farm of the bird. More attention from the local authority by means more effort on supporting bird conservation program and increasing law enforcement to protect bird habitat and combat illegal poaching.
