MONTHLY PROGRAMME ACTIVITY REPORT

JULY 2013

SUMMARY

MKT's interventions on the mountain continued during a mostly dry, cold and windy month. All field based teams worked in tandem with KFS, KWS and other law enforcement agencies including Lewa, Marania and Kisima security. Project areas highlighted in this month's programme report are:

- Community Environmental Education and Awareness
- Fencing Initiatives
- The Joint Wildlife Protection Team
- Marania Wildlife Guards
- The Horse Patrol Team
- The Elephant Corridor
- Workshops and Meetings

The report covers MKT activities for the period 30th June to 31st July 2013. Reports were provided by the following employees: Humphrey Munene on Education and Awareness initiatives as well as fencing work. Northern sector reports were provided by the following; the Marania Wildlife Guards¹; the Elephant Corridor Team², the Horse Patrol Team as well as the northern area supervisor - Maurice Thure on interrelated aspects. Southern sector updates were collated by the Joint Wildlife Protection Team³ led by Edwin Kinyanjui Ngure. The July report was compiled by Maurice Nyaligu.

1. INTRODUCTION

Programmatic activities discussed during this month's field interventions are:

- Illegal logging
- Snaring of wildlife and poacher related incidents
- Elephant mortality incidents
- Other wildlife mortality incidents
- Illegal growing of marijuana (*Cannabis sativa*)
- Arrests and apprehensions
- Charcoal burning and illegal firewood collection

1.1 Programme patrol and operational areas

The following project activity areas were patrolled by field based teams this July. These are:

- Elephant Corridor Fencing Team Marania to Kisima line, Marania gate, and the Kamiti fence line
- Marania Wildlife Guards Marania forest, Ngaita area, Daraja ya Charlie, Kisima section (Chumvi area), Equator area, Kiwanja ya Dyre, Corridor area, Mlima Dinga, Kimbo area (Kianjuri section), Chemi Chemi ya Ndovu area, Mlima Ngaita, Mlima Suruai and Corridor route
- Horse Patrol Team (HPT) School of Adventure area, Solo Camp, Embori zone, Marania forest, Embori forest, Corridor, Mlima Ngaita zone, Zorilla camp forest and the Marania river side
- Joint Wildlife Protection Team (JWPT) Ruthumbi area and parts of Themwe
- Field Coordinator Meru County (Ruthumbi and Ntirimiti) for Education and Awareness initiatives and Fencing work

2. PROJECT UPDATES

2.1 Illegal logging



As summarized in the table below, the JWPT and the Marania Wildlife Guards field teams reported several cases of illegal logging. Logging was cross-cutting with the most affected tree species being Red cedar (*Juniperus procera*), Rosewood (*Hagenia abyssinica*), Cypress (*Cupressus lusitanica*) Camphor (*Ocotea usambarensis*) and Podo (*Podocarpus spp.*). The work of the JWPT also revealed illegal logging in Ruthumbi to be on-going in conjunction with illegal marijuana (*Cannabis sativa*) growing and snaring of small and large mammal species.

2.3 Elephant mortality incidents

At least two elephant mortality incidents were reported by the Joint Wildlife Protection Team in the Ruthumbi area of Mount Kenya this July. Details of these incidents are summarized in

2.4 Other wildlife mortality incidents

A waterbuck carcass was reported by the Marania Wildlife Guards on the 21st of July at about 1245hrs. The incident was encountered while the Guards were patrolling the Elephant Corridor along waypoint 37M 0328934, UTM 0007865. It is suspected the bull sustained injuries during ritual fighting with other males for females. A section of the stomach had been predated upon.



2.5 Illegal growing of marijuana (*Cannabis sativa*)

These incidents were reported by the JWPT on several dates within Ruthumbi. On 17th July, 5 acres of the plant were discovered following tip-off by members of the community. The incident was recorded at 1320hrs along waypoint 37M 0332791, UTM 9982716. Several huts used by the



marijuana growers' were identified and destroyed through the combined efforts of MKT, KWS and KFS. A section of the plantation had already been harvested, but the team managed to uproot at least ninety five (95) live stems. On the 22nd of July following additional leads, the team discovered and destroyed a number of huts (at three localities) deep within the forest reserve;



these huts are suspected to be used by bhang growers. In the process, at least five (5) sacks of harvested bhang were discovered and burnt as were three (3) acres of marijuana plantation.

2.6 Arrests and apprehensions

Only one logical arrest relating to Cannabis sativa growing was reported by the JWPT this July. On



the 25th of July at about 1800hrs, the team managed to arrest two men: David Kinoti Mandiu and Patrick Mutuuri Nkanata ferrying bhang from the forest in two sacks of about 18kgs each. The two were booked at Nkubu Police station under OB: No. 46/25/07/13.

2.7 Charcoal burning and illegal firewood collection

Illegal charcoal burning was reported by the Joint Wildlife Protection Team on the 2nd of July. This incident was recorded along waypoint

37M 0339304, UTM 9986722 at about 1544hrs. No other incidents were reported by the teams.

2.8 Littering and garbage disposal

At least one incident of littering and garbage disposal in the forest reserve was reported by the Marania Wildlife Guards this month. This incident was observed on the 14th of July while the team was on patrol in the Chemi Chemi ya Ndovu area along waypoint 37M 0327142, UTM 0006008. Littering and garbage disposal is suspected to originate from members of the immediate surrounding community as well as illegal loggers and grazers within the national forest reserve.

2.9 Habitat destruction by elephants and rains

Elephants were reported to have destroyed a number of trees on at least three occasions within the northern section of the mountain this July. On the 5th of July at about 1124hrs, several rosewoods were noted to have been felled by elephants along waypoint 37M 0325336, UTM 0007371. The

incident was recorded at Mlima Ngaita by the Horse Patrol Team. A similar incident was reported by the same team in Embori area along way point 37M 0311965, UTM 0005330 at about 0844hrs. Heavy rains also contributed to some destruction in the area. Following heavy rains on the 13th of July, the HPT reported several red cedars that had fallen along waypoint 37M 0313144, UTM 0004779. Within the Corridor, however there were no major incidents involving elephants, although a number of indigenous and exotic trees were reported to have been debarked or uprooted.

2.10 Community education and awareness initiatives

Community members were the target of the Trust's outreach education and awareness programme



this July. These interventions were undertaken in public market centers near the Ruthumbi Forest Station in Meru on diverse dates of the month. The two short documentary films 'Wanted Dead or Alive' and 'Running Dry' were aired to convey environmental challenges facing the mountain. Ruthumbi was chosen for this particular activity based on its significance as an area notorious for poaching and snaring. The JWPT has been stationed in the area for well over a month now, and the number of snares retrieved by the

team has been significant and on the rise. Following the screening, a section of the community approached KWS and offered to avail information on poaching and other related illegal activities. This intelligence was partly responsible for discovery of the illegal Bhang (*Cannabis sativa*) fields. Both the KFS and the KWS are following on additional leads and more suspects may be arrested

soon. The airing of the short documentary 'Running Dry' also elicited some reaction from the general public. A segment of the community exhibited disappointment as to how a few greedy individuals had plundered important forest resources. In general and overall, community members were made to understand and appreciate how forests neigbouring their immediate vicinity if destroyed, not only affects community members, but wildlife and the general economy of the country too.



2.11 Fencing initiatives

Despite last month's enforcement measures, a herd of elephants managed to break the Ntirimiti short fence along three different sections of the line. The likely explanation has been prevailing



cloudy and windy conditions in July, the solar panels are not harnessing enough solar energy to recharge the batteries. This position has been authenticated by the technician in charge who says the fence line records no voltage at dawn. The damaged sections were nevertheless repaired by a community fence attendant with assistance of the MKT Corridor fencer. Voltage through the fence lines however will continue to be low during the night due to insufficient solar energy in the day. It is hoped that with the onset of

August, weather conditions will improve for the better.

2.12 Workshops and meetings

Elephant mortality harmonization meeting

This July there was a 2nd harmonization meeting on elephant mortalities for the Laikipia /Samburu MIKE reporting site held at the Old House in Nanyuki. The meeting was facilitated by KWS and

representation was broad across the spectrum; the Trust was represented by Maurice Nyaligu. Although Mount Kenya is not considered part of the reporting sites under MIKE, its elephants range across the ecosystem and it's imperative that they are incorporated in the harmonization. A total of 102 elephant mortality incidents were reported for the period January to June 2013. Of this total, 61 were reputed to have resulted from poaching while 27 were due to natural factors; the rest were either unknown or the result of problem animal control due to human wildlife conflict. The meeting also deliberated on modalities of how to respond to poaching incidents within certain hotspot areas which continue to exhibit perennial poaching incidents such as in the Rumuruti forest. KWS has formed a national Elephant Conservation Committee that is expected to redress these concerns. In the interim, the Trust is to receive an official invite from KWS and will be represented at the inaugural launch on 29th August this year.
