Sustainable Financing for Mozambique's Protected Areas

ne of the key challenges to global biodiversity conservation is the lack of finances for effective management of protected areas (PAs). In order to achieve financial sustainability for its national system of PAs, Mozambique will need to assess the system's current financing needs and develop a national sustainable financing strategy. This strategy must identify options for generating revenue and address legal, regulatory, and institutional reforms needed to achieve financial sustainability.

A protected areas system imposes numerous costs upon a nation, but there is a significant body of evidence from around the world that indicates that the cost of maintaining a PA system is often balanced by the substantial social, economic, and environmental benefits generated by the services provided by the system. The cost-benefit case for investment has yet to be explored in Mozambique. Like many countries, Mozambique has not capitalized on the potential for Payments for Ecosystem Services (PES) to both secure sustainable financing for Mozambique's PAs and to promote local community stewardship of vital natural resources which can result in improving livelihoods in local communities. Therefore, a strategy for the sustainable financing of Mozambique's protected areas is urgently needed.

In November 2007, the first conference on the Sustainable Financing of Mozambique's Protected Areas Project was organized by WWF-Mozambique, in collaboration with WWF-US, Agence Française de Développement, Kreditanstalt Für Wiederaufbau (German Development Bank), and

the United States Agency for International Development. The conference brought together about 100 national and international experts to brainstorm recommendations for a sustainable PA financing initiative based on enhanced understanding of ecosystem services and how these services can contribute to national economic growth and poverty alleviation. One of the key recommendations of the conference was the need to conduct a feasibility study to assess the potential for creating a conservation trust fund to support Mozambique's conservation areas. Mozambique's Conservation and Biodiversity Committee, chaired by the Ministry of Tourism, has requested that WWF commission this study. The overall objective is to explore the feasibility of creating a national-level conservation trust fund in Mozambique and to recommend a follow-up strategy for implementation, including recommendations regarding design options such as conservation strategies for distributing the fund's proceeds. This project will serve as a catalyst to support the development of a national sustainable financing strategy for Mozambique's PA system. Lessons learned on policy reform in other regions, effective financial

management and planning, and a variety of sustainable financing mechanisms will be critical to support the development of this strategy. The project will also promote greater coordination among stakeholders and increase the capacity of local actors to engage in policy reform, sustainable finance planning, and project implementation at the national level.

The feasibility study will also be used to raise awareness of the importance of sustainable financing for Mozambique's PAs and will consist of an overall review of relevant environmental, biodiversity, and conservation plans, programs, studies, and legal framework in Mozambique. It will include a compilation of stakeholder input from local communities, the private sector, academic institutions, government agencies, and non-governmental organizations as well as identify potential donors and discuss short and long term contributions. The final strategy will incorporate timetables, performance benchmarks, a list of required specialists, and an estimated budget. The study will conclude in April 2008.
